INVITING COMMENTS ON THE PROPOSED AMENDMENTS IN THE
BSF WATER WING GROUP 'C' POSTS RECRUITMENT RULES– 2013

In compliance of MHA (Pers-II) UO No.I-45023/6/2015-Pers-II dated 20.10.2015 regarding discontinuations holding of interview for recruitment to Group 'B', 'C', & 'D' posts in the Ministries of Government of India and the attached/subordinate offices/other organizations under the control of Ministries. Border Security Force proposes to amend the Border Security Force Water Wing Group 'C' posts, Recruitment Rules – 2013, for the posts of Head Constable (Master), Head Constable(Workshop), Head Constable (Engine Driver) and Constable(Crew) having the Grade Pay of Rs.2400/- and Rs.2000/-, to dispense Interview and to revise Visual Standard as per New Policy Guidelines on recruitment/retention in respect of Central Armed Police Forces (CAPFs) and Assam Rifles (ARs) personnel having defective vision including colour blindness as per MHA (P-II) letter dated 20th Oct 2014. Accordingly, the proposed Border Security Force Water Wing Group 'C' posts, Recruitment (Amendment) Rules – 2016 have been prepared and required to be circulated.

Notification

G. S. R. ___ In exercise of the powers conferred by clauses (b) and (c) of sub-section (2) of section 141 of the Border Security Force Act, 1968 (47 of 1968), the Central Government hereby makes the following rules to amend the Border Security Force Water Wing Group 'C' posts, Recruitment Rules, 2013, namely: -

1. (1) These rules may be called the Border Security Force Water Wing Group 'C' posts, Recruitment (Amendment) Rules, 2016.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Border Security Force Water Wing Group 'C' posts, Recruitment Rules, 2013,-

(a) against serial number 1, relating to the post of Head Constable(Master), in the existing entries under column (7), for item numbers (4) and (5), the following items shall be substituted, namely:-

“(4) Medical Standards.-

(i) Eye Sight-
