**INVITING COMMENTS ON THE PROPOSED AMENDMENTS IN THE**  
**BSF ENGINEERING SET UP (CIVIL) COMBATANT GROUP 'C' POSTS**  
**RECRUITMENT RULES– 2013**

In compliance of MHA (Pers-II) UO No.I-45023/6/2015-Pers-II dated 20.10.2015 regarding discontinuations holding of interview for recruitment to Group 'B', 'C', & 'D' posts in the Ministries of Government of India and the attached/subordinate offices/other organizations under the control of Ministries. Border Security Force proposes to amend the Border Security Force Engineering Set Up (Civil) Combatant Group 'C' posts, Recruitment Rules – 2013, for the posts of Head Constable (Fitter/Blacksmith, Carpenter/Mason, Plumber, Welder, Pump Operator), Head Constable/Pioneer, Head Constable/Technical, Constable (Carpenter, Plumber, Welder & Mason) and Constable (Sewerman) having the Grade Pay of Rs.2400/- and Rs.2000/-, to dispense Interview and to revise Visual Standard as per New Policy Guidelines on recruitment/retention in respect of Central Armed Police Forces (CAPFs) and Assam Rifles (ARs) personnel having defective vision including colour blindness as per MHA (P-II) letter dated 20<sup>th</sup> Oct 2014. Accordingly, the proposed Border Security Force Engineering Set up (Civil) Combatant Group 'C' posts, Recruitment (Amendment) Rules – 2016 have been prepared and required to be circulated.

In terms of DoP&T OM No.AB-14017/61/2006-Estt(RR) dated 13 Oct 2015, draft amendments have been uploaded to the **website of BSF and on IPP**, for comments on the proposed Notification of BSF, Engineering Set up (Civil) Combatant Group 'C' posts, Recruitment (Amendment) Rules, 2016 from all stakeholders in the following format:-

G. S. R. \_\_\_ In exercise of the powers conferred by clauses (b) and (c) of sub-section (2) of section 141 of the Border Security Force Act, 1968 (47 of 1968), the Central Government hereby makes the following rules to amend the Border Security Force Engineering Set up (Civil) Combatant (Group 'C' posts) Recruitment Rules, 2013, namely: -

1. (1) These rules may be called the Border Security Force Engineering Set up (Civil) Combatant (Group 'C' posts) Recruitment (Amendment) Rules, 2016.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Border Security Force Engineering Set up (Civil) Combatant (Group 'C' posts) Recruitment Rules, 2013, in the Schedule,

(1) against serial number 1 relating to the post of Head Constable (Fitter/Blacksmith, Carpenter/Mason, Plumber, Welder, Pump Operator), under column (7) relating to Educational and other qualifications required for direct recruits, for items (c) and (d) and the entries relating thereto, the following shall be substituted, namely,-

“(c) Medical Standards:

(i) Eye Sight :

Visual Acuity unaided (NEAR VISION)		Uncorrected Visual acuity (Distant Vision)		Refraction	Remarks
Better eye	Worse eye	Better eye	Worse eye		
N6	N9	6/6	6/9	Visual correction of any kind is not permitted even by the glasses	In right handed person, the right eye is better eye and vice versa. Binocular vision is required

(ii) The candidates must not have knock knee, flat foot, varicose vein or squint in eyes and they should possess CP III BY ISIHARA vision.

(iii) The candidates must be in good mental and bodily health and free from any physical defect likely to interfere with the efficient performance of the duties.

(d) Must qualify technical aptitude and trade test both in written and practical”;
