

Notification

New Delhi, dated the ___ 2016

G. S. R. ___ In exercise of the powers conferred by clauses (b) and (c) of sub-section (2) of section 141 of the Border Security Force Act, 1968 (47 of 1968), the Central Government hereby makes the following rules to amend the Border Security Force, Constable(Tradesman), Group 'C' posts, Recruitment Rules, 2010, namely: -

1. (1) These rules may be called the Border Security Force, Constable(Tradesman), Group 'C' posts, Recruitment (Amendment) Rules, 2016.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Schedule to the Border Security Force, Constable (Tradesman) Group 'C' posts, Recruitment Rules, 2010, against the posts of Constable (Tradesmen).-

(i) in column (8), for the entries, the following shall be substituted, namely:-

“(a) Matriculation or equivalent from a recognised University or Board with-

(i) two years work experience in respective trades; or

(ii) one year certificate course from Industrial Training Institute or Vocational Institute with at least one year experience in the trade; or

(iii) two years Diploma from Industrial Training Institute in the trade or similar trade.

(b) Must qualify trade test.

Note: Multi-skilled candidates will be given preference.
