G. S. R.- In exercise of the powers conferred by clauses (b) and (c) of sub-section (2) of section 141 of the Border Security Force Act, 1968 (47 of 1968), the Central Government hereby makes the following rules regulating the method of recruitment to the Group 'B' and 'C' posts of Para Veterinary Staff (Combatised) in the Border Security Force, in the Ministry of Home Affairs, namely :-

1. Short title and commencement.- (1) These rules may be called the Border Security Force Para Veterinary Staff, Group 'B' and 'C' posts (Combatised) Recruitment (Amendment) Rules, 2016.

(2) They shall come into Force on the date of their publication in the Official Gazette.

2. In the Border Security Force Para Veterinary Staff, Group 'B' and 'C' posts (Combatised) Recruitment Rules, 2014,

(a) for rule 2, the following shall be substituted, namely:-

2. Number of posts, classification and pay band and grade pay or level in the pay matrix.-

The number of said posts, their classification and the pay band and grade pay or level in the pay matrix attached thereto shall be as specified in column(2) to (4) of the Schedule annexed to these rules.
