

- (d) In case of wards of killed in militant action & medically boarded out, Post-mortem/copy of pension payment order(PPO) and copy of Medical board proceedings in support of wards of killed in militant action and medically boarded out cases respectively.
- (e) The sponsored wards of BSF Widows/Serving/Retired/Medically boarded out under your command to appear in the entrance test conducted by the beneficiary State/UT/Govt, Department. If the beneficiary State/UT/Govt .Department is not conducting any examination the selection will be made on the basis of marks obtained by the students in All India Pre-Medical Entrance Test(AIPMT) conducted by CBSE. **In any circumstances, the selection of students will not be made merely on academic merit of 10+2 marks.**
- (f) Incomplete application/ and application received after **30th June'14** will not be considered.
- (g) Any change in criteria in method/system if any received from MHA will be communicated subsequently.
- (h) This should be circulated all troops / retired/widows accordingly in time.
