In partial modification of this office order No. 36/1/86/2009-Fin/BSF/6051-6411 dated 22<sup>nd</sup> Dec 2009, I hereby convey the delegation of financial powers of the DG BSF under Rule 13(3) of Delegation of Financial Power Rules 1978 (as amended) as per annexure attached, to the Spl DG, Addl DG, IG(Admn) FHQ, IsG Ftrs HQrs, DIsG Sector HQ, Training Institutions and Commandants of the Bns in respect of Major Works, Minor works, Repair/Renovation/Alteration in existing buildings, Execution of Petty Works and Special repairs to be executed to the BSF.

2. These powers will be subject to the following conditions as stipulated under MHA Order No.II-27012/29/2005-PF-I(Part-I) dated 12<sup>th</sup> Oct 2011:-

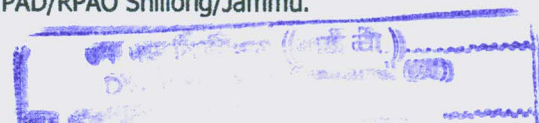
- (i) All codal formalities for procurement should be followed as prescribed under the relevant rules.
- (ii) All the conditions prescribed under GFRs 2005 and Sub subsequent instructions issued from time to time are fulfilled.
- (iii) Procedures for procurement of goods and service laid down in the Manual on Policies and Procedures for Purchase of Goods, for procurement of services and works, issued by Ministry of Finance will be complied with.
- (iv) The above delegation is subject to availability of funds in the budget as well as guidelines laid down in the DFPRs and instructions issued from time to time, on the subject, by the Ministry of Finance and this HQrs, particularly HQ BSF DO No.122/01/2011/Engg/BSF/354-576 dated 24<sup>th</sup> Oct 2011.
- (v) These powers should be exercised in consultation with the Internal Financial Advisor.

3. These delegated powers shall be exercised by the CFAs in consultation with Dy FAS for the Works which have been prioritized and approved by Force HQrs within the authorisation. If the proposal is beyond the prioritized programme and/or beyond authorisation, the same should be submitted to Force HQrs for sanction irrespective of the amount involved.
