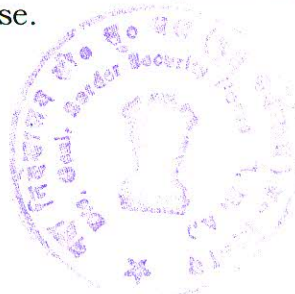

The undersigned is directed to refer to this Ministry's O.M. of even number dated 09.09.2014 alongwith a statement indicating the number of MBBS/BDS seats and the Medical/Dental Colleges allocated by Ministry of Health & Family Welfare to Ministry of Home Affairs from the Central Pool quota for the academic session 2014-15 on the above noted subject.

2. Besides, a copy each of the lists drawn on the basis of merit for the MBBS seats and BDS seats allotted to this Ministry for the academic session 2014-15 is enclosed. The lists contained number of candidates more than the seats allocated to MHA for the purpose of counseling as some candidates though falling in merit may not come for counseling or may be unwilling to join the Course in the allocated college due to any reason. The right for selection will be passed on to the next meritorious and eligible candidate in such an event.

CAPFs concerned and AR are requested that the eligible candidates from the enclosed lists (Annexure-I & II) may be informed for counseling to report on **27.09.2014 (Saturday) at 03.00 P.M. in Room No.119 (Conference Hall), North Block, New Delhi** accompanied by parent/guardian (one only) alongwith all original educational certificates/ documents including their 4 recent passport size photographs for the counseling. Failure to report for counseling on due day i.e. 27.09.2014 (Saturday) at 03.00 P.M. will be passed over to the next candidate in merit. They are also requested to be prepared to report the Medical College on the very next day, if so required, as the last date to report to the allocated college for admission with all relevant documents is 30.09.2014 which will not be extended in any case.

In case the candidate is not willing to attend the above counseling, a letter/undertaking for the same from the applicant with reasons may be obtained to this effect and sent to this Ministry before the date of counseling to avoid any representation or legal complication at a later stage. Such an undertaking be signed by the candidates as well as his/her parent/guardian.
