OPTION THEREOF

Many SI/JEs(GD) appointed against the transferred post of SI/GD/Comn/MT have been applying time to time for their absorption/promotion in Engineering cadre but could not be agreed upon by Department due to various reasons. As a result many of such candidates have been submitting representations/writ petitions for their absorption / promotion in Engineering set up.

02. In view of above, the department has taken a holistic view to consider the absorption of all similarly situated pers in Engineering set up in accordance with their inter-se-seniority based on date of initial appointment as SI/JE(GD) and as per their eligibility in accordance with Recruitment Rules, subject to availability of vacancies.

03. An option on affidavit is required to be submitted by such candidates. However, this development may be brought into the notice of other similarly situated pers/Engineers and also give it wide publicity to avoid unwarranted representations at the later stage. The letter regarding option of affected individual are attached for necessary action at your end, please.

SUB :- **PERMANENT ABSORPTION IN ENGINEERING SET UP :**
IRREVOCABLE OPTION THEREFOR

During expansion stage, adequate Engineering Staff was not sanctioned to cope up with the requirement of maintenance / construction work in BSF. As a result certain posts of SI / GD / Comn / MT were filled up by candidates, having 03 years diploma in Engineering. Majority of these officials have been working with Engg Set up throughout their career. Many of such officials have been applying time to time for their absorption / promotion in Engineering cadre but could not be agreed upon by Deptt owing to their appointments against the post of GD and other tech aspects related thereto. Due to non absorption in Engg Set up, many of such candidates have filed writ petitions or submitted representations for their absorption / promotion in Engg Set up.

02. Apropos to the above, the whole issue has been re-examined in totality. The deptt intends to settle the issue by considering above mentioned officials for absorption in Engg Set up in accordance with their inter-se-seniority based on date of initial appointment as SI / JE (GD) and as per their eligibility in accordance with RRs, subject to availability of vacancies.

03. While preparing inter-se-seniority, instructions issued by GOI and the seniority of already absorbed pers in Engineering set up and Direct entry Engrs will also be taken into account. However, it may be brought to your

notice that, at present adequate vacancies are not available as such you will likely to be accommodated in Engg Cadre on availability of vacancies only as per your seniority.

04. In view of above, if you are willing to submit option on affidavit duly notarized by the notary public as per format mentioned in appendix – "A" enclosed to this letter for considering your cases for absorption in Engg set up in accordance with existing instructions, subject to availability of vacancies. Please send your option to reach this HQr through respective FTR within one month from the date of issue of this letter. No conditional option will be entertained at any stage and it will be rejected straightway.

- (a) That, I joined BSF as Sub Inspector / Junior Engineer (General Duty) against the transferred post of Sub Inspector (General Duty) on _____ and serving / had served against GD post only in Engg Branch.
- (b) That, In response to Personnel Directorate BSF L/No.45011/83/2006/Staff(E)/BSF / 11822-82 dated 15th Oct 07, I do hereby give my irrevocable option for absorption in BSF Engg cadre as per my seniority to be reckoned from my date of initial appointment in BSF subject to availability of vacancy in the rank, I am to be absorbed.
- (c) That, I will not withdraw or amend or alter this option in future for any reasons whatsoever.

- (g) That, I will render my technical resignation from the present post before absorption in Engineering Set up and will accept the designation/post so offered by the Deptt as a sequel to exercise of this option.
- (h) That, after absorption, I shall be governed by the rules and other instructions issued by the Govt. of India for the post I am absorbed as a sequel to this option.
- (j) That, I will withdraw the Writ Petition from the Court of Law on acceptance of option / absorption in Engg Set-up by DG BSF.
