Subject:- **FILLING UP OF THE POSTS OF SECOND-IN-COMMAND (ELECTRICAL) NON MINISTERIAL (COMBATISED POST) IN BSF ON DEPUTATION BASIS**

The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/ department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall not be exceeding 52 years as on the closing date of receipt of applications.)</p>


