Applications are invited from male/female Indian citizens for appointment on combatised post of Assistant Sub-Inspector(Proof Reader) in Border Security Force, Ministry of Home Affairs, Government of India in the pay scale as mentioned below plus DA and other allowance as admissible to the member of the Force from time to time as well as accommodation, uniform, LTC and medical facilities etc. The post is temporary but likely to become permanent.

3. ELIGIBILITY CONDITIONS

A) EDUCATIONAL QUALIFICATION

- Degree or equivalent with English and Hindi as subjects from a recognized University.
- Two years experience in proof reading from an authorized Printing Press/Newspaper office and knowledge of printing work.

iv) **Medical Standards:-**

- (a) Eye sight - The minimum distant vision should be 6/6 to right eye and 6/12 to left eye or 6/9 both eyes without optical device.
(b) Tattoo: - Candidates having permanent tattoo on any part of the body will be debarred for recruitment in CAPFs.
(c) Candidates should be medically fit in all respects.

C) AGE LIMIT

i) Between 18 to 25 years. Upper age limit is relaxable for Govt Servants in accordance with the instructions and orders issued by the Central Govt from time to time.

ii) The upper age limit will be further relaxable upto 05 years to candidates of Jammu and Kashmir who have ordinarily been domiciled in the State of Jammu and Kashmir during the period from 01.01.1980 to 31.12.1989(Any person intending to avail of the aforesaid relaxation shall submit the certificate from either District Magistrate within whose jurisdiction he had ordinarily resided or any other authority so designated in this behalf by the Govt of J&K to the effect that he had ordinarily been domiciled in the State of Jammu and Kashmir during the period from 01.01.1980 to 31.12.1989).

iii) The relaxation in upper age limit of 05 years shall also be admissible to the children and dependent family members of those who were killed in the communal riots of the year 1984 and Gujrat of the year 2002. For getting this benefit, the children and dependent family members of those killed in the riots should produce a certificate to that effect from the concerned District Collectors. A candidate can apply against vacancies in any State/ UT if he fulfills other conditions, however, to avail of the present relaxation he/ she has to produce the certificate from the District, wherein the victim was killed.

Note:- The crucial date for determining the age-limit shall be the closing date for receipt of applications from candidates in India and not the closing date prescribed for those in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh Division of Jammu and Kashmir State, Lahaul and Spiti District and Pangj Sub-Division of Chamba District of Himachal Pradesh, the Union Territory of the Andaman and Nicobar Islands or Lakshadweep.

4. APPLICATION FORM, FEES AND CENTRE OF EXAMINATION

4.1 Proforma of application form given in **Annexure-I** to this advertisement.

4.2 Each application should be accompanied by a crossed Demand Draft/ Postal Order for Rs.100/- as examination fee in favour of Commandant 25 Bn BSF. Demand Draft should be payable at SBI- Najafgarh A.D.B., Code-1419. Postal Order should be payable at Post Office-Najafgarh. However, the SC/ST candidates are not required to submit examination fee. **Women candidates are also exempted from payment of examination fees.**

Candidates will submit their applications to "The Commandant, 25 Bn BSF, Chhawla Camp, Najafgarh, New Delhi-110071. Candidates serving in Central Govt/State Govt/Public Sector Undertaking applying for the post will submit the application through proper channel.



5. SUBMISSION OF APPLICATION

The candidates may utilize the application format given with this advertisement and send the application so as to reach at the above mentioned center on or before 30th October 2016. Last date for receipt of applications in respect of candidates belonging to far flung areas of Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh Division of Jammu and Kashmir State, Lahaul and Spiti District and Pangi Sub-Division of Chamba District of Himachal Pradesh, the Union Territory of the Andaman and Nicobar Islands or Lakshadweep 14th November 2016. The application should be accompanied with self attested copies of certificates as proof of age, educational qualification, experience certificate, caste, tribe/ hill areas (domicile), wherever applicable.

6. SELECTION PROCEDURE

The selection shall be held in two phases as under:-

(a) First Phase

(i) Written Examination

(b) Second Phase

- (i) Physical Standard Test(PST)
(ii) Physical Efficiency Test(PET)
(iii) Trade Test
(iv) Documentation (Checking of Documents)
(v) Medical Examination

There shall be sufficient gap between two phases of the tests.

7. A) FIRST PHASE

Written Examination

The written examination will be conducted at 25 Bn BSF Chhawla Camp, New Delhi on the date and time fixed by Pers Dte (Recruitment Section) HQ DG BSF which will be communicated on completion of the scrutiny. Admission in written examination will be purely on production of call letter/ admit card dispatched to the eligible candidate by the centre. There will be two composite papers of following parts.

(a) PAPER-I:

Paper-I will be for **one hour and forty minutes** duration consisting following three parts and will be "OMR BASED OBJECTIVE TYPE WITH MULTIPLE CHOICE".
