

- (i) The offer of engagement of above selected General Duty Medical Officers will be issued subject to number of actual vacancy in particular BSF location according to the willingness of the candidates and also subject to completion of procedural formalities.
 - (ii) The offer of contractual engagement is provisional and subject to character and antecedent verification.
 - (iii) Candidates available in waiting list if willing for another location (Field units) will be considered by the respective Recruitment Centre for contractual engagement subject to vacancy and suitability.
 - (iv) The Specialist and GDMOs appointed on contractual basis when deployed for out station duties (to be determined by the Commanding Officer) are eligible for TA/DA. However, no LTC and Railway warrant will be granted / issued to them.
