5. **Instructions to Bidders: -**

**DELIVERY OF STORES**

Firm should not deliver Stores to consignee(s) beyond scheduled Delivery Period without obtaining prior sanction of purchaser.

In case, Firm deliver Stores after scheduled Delivery Period, even if the stores are accepted by the consignee, it would be at the risk and the cost of the Supplier as the supply may not be taken as contractually accepted.

**PENALTY FOR DELAY IN SUPPLY AND LIQUIDATED DAMAGES:**

Penalty @ 2% per month or part thereof of the contract value shall be levied for delay in supply subject to a maximum of 10% in the form of LD.

In case the firm does not complete the supply within the delivery period, action will be taken against the firm as per Para 15.7 of DGS&D Manual and Para 14.7 (i) of Ministry of Commerce, Deptt of Supply of the General condition of the contract.

**Inspection**

- (a) Authority : DIG BSF or his authorized Rep.
- (b) Survey of Store : (i) Survey /inspection of the stores will be carried out by QC Section, SIW BSF on receipt of stores.
- (ii) If any lot/ items is rejected during final inspection /survey as not conforming to specifications the same must be replaced before final acceptance.
- (iii) The consignee's right of rejection in this regard will be final and absolute.
- (iv) Survey of stores including QC Test will be carried out within 07 days from the actual date of delivery of stores.

**PAYMENT TERMS** : 100 % Payment of the stores supplied will be released on completion of successful survey /QC Test
