- Earnest money in the form of Treasury Challan/Demand Draft/Pay order or Banker's Cheque /Deposit at Call Receipt of any Scheduled Bank issued in favour of **DDO, ADM-III, FHQ BSF New Delhi**.
- Valid Enlistment order, electrical licence of the Contractor and PAN Card.
- Certificates of similar type of work experience as per para 1.2.1 of CPWD-6
- Registration certificate under GST.
- The tenderer shall have to furnish an affidavit as under:-

"I/We undertake and confirm that eligible similar work(s) has/have not been got executed through another contractor on back to back basis. Further, if such a violation comes to the notice of Department, then I/We shall be debarred for tendering in BSF/CPWD in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-charge shall be free to forfeit the entire amount of the Earnest money /Performance Guarantee."

3. The original EMD should be deposited in the office of Assistant Engineer inviting bids within the period of bid submission i.e. on or before **29th June' 2018 up to 1200 hrs** failing which bid submitted shall become invalid.
