**/// PUBLIC AUCTION ///**

A public auction will be conducted on behalf of the President of India, on **11<sup>th</sup> July, 2018** at **11.00 hrs** at **STS BSF, Tigri Camp, M B Road, New Delhi-80** to dispose of unserviceable/condemned retrieved materials of Misc, MT, Construction, Trg and Technical, welfare, canteen and various messes stores through Public Auction.

2. The materials will be sold/auctioned on the basis of "AS IS WHERE IS" Interested bidder/parties who have PAN Card may attend the auction on the date and time as mentioned above. Apart from PAN Card, bidder/parties have to provide their GSTIN / Service Tax Number at the time of auction.
3. An amount of **Rs. 5,000/- (Rupees Five Thousand) only** shall be deposited by cash by each bidder as earnest money before the commencement of the auction. No bidder will be eligible to participate in the public auction without depositing of Earnest money.
4. The auction will be held as per departmental rules and regulations. The Board of Officers who will conduct the auction reserves full rights to reject / accept the auction whole or lot without assigning any reason. In case of any doubt or clarification raised by any bidder, Presiding Officer of the board will give decision on the spot which will be accepted by all concerned.
5. Payment for the materials auctioned will be/to be made by the successful bidder (s) in cash on the spot at the time of finalization of auction. GST as admissible will be charged extra.
6. The auction materials should be removed from the BSF premises by the bidder (s) at his own expenses on the same day itself. No transport/carriage will be provided by this Institution for removal of materials from the auction site.
7. In case of sufficient numbers of bidders not present at the time of auction, the auction will be postponed. Govt employee(s) other than those of BSF will also be eligible to participate in the auction.
8. The earnest money deposited will be refunded immediately on completion of the auction proceeding except the successful bidder (s), which will be adjusted into bid amount.
9. In case of the bidder fails either to deposit bid amount or to remove the materials from the site of auction within the stipulated time period i.e. 24 hrs, the department will be at liberty to forfeit the earnest money deposit, or to charge the ground rent at the prevailing market rates, as the case may be.
