
e) Under taking for submission of EMD and eligibility documents:-

“ The physical EMD & other eligibility documents shall be deposited by me/us with the EE calling the bid in case I/we become the lowest bidder within a week of the opening of financial bid otherwise department may reject the bid and also take action to debar me/us from tendering in BSF and Enlistment Department may also take action against me/us to debar me/us from tendering in Department”.

f) The tenderer shall have to furnish an affidavits as under:-

Further, if such a violation comes to the notice of Department, then I/We shall be debarred for tendering in BSF in future forever.
