PUBLIC AUCTION NOTICE

A public auction will be conducted on behalf of the President of India on 16th Aug 2018 at 1100 hrs at STS BSF Tigri camp, M B Road, New Delhi- 80 for dispose of condemned "08 Nos Single NGO's Qtrs" held in charge of STS BSF Tigri camp, New Delhi by public auction.

2. The building will be sold / auctioned on the basis of "AS IS WHERE IS". Interested bidder / parties who have valid PAN Card, Registration certificate etc. may attend the auction on the date and time as mentioned above.
3. An amount of **Rs. 10,000/- (Rupees Ten Thousand)** only shall be deposited by cash by each bidder as earnest money before the commencement of the auction. No bidder will be eligible to participate in the auction without depositing of Earnest money.
4. The auction will be held as per departmental rules and regulations. The Board of Officers who will conduct the auction reserves full rights to reject / accept the auction whole or lot without assigning any reason. In case of any doubt or clarification raised by any bidder, Presiding Officer of the board will give decision on the spot which will be accepted by all concerned.
5. Payment for the building auctioned will have to be made by the successful bidder (s) in cash on the spot at the time of finalization of auction. VAT / GST as applicable will be charged extra.
6. The auction building should be removed from the BSF premises by the bidder (s) at his own expenses **within 45 days**. No transport / carriage will be provided by department for removal of materials from the auction site.
7. In case of sufficient numbers of bidders not present at the time of auction, the auction will be postponed.
8. The earnest money deposited will be refunded immediately on completion of the auction proceeding except in the case of successful bidder (s), which will be adjusted into bid amount.
9. In case of the bidder fails either to deposit bid amount or to remove the building from the site of auction within the stipulated time i.e. 45 days , the department will be at liberty to forfeit the earnest money deposit, or to charge the ground rent at the prevailing market rates , as the case may be.
10. The administration is not responsible for any loss or devaluation or the quality of the article / materials found while dismantling and it will be at the total responsibility of the successful bidder. The bidder should carry out the job within the given time limit at his risk and cost and with all safety provisions required for the job. The bidder will be responsible for any type of accident and compensation / claims which may arise.
11. Any type of default in carrying out the job will result in legal action against the bidder and EMD / Security deposit will be forfeited.
