

- The quotation shall be submitted in the office of the Command HQ SPL OPS, 3<sup>rd</sup> floor, E1 & E2 Block, Pushpa Bhawan, New Delhi in sealed cover through Post or through tender box. Unsealed quotation shall be summarily rejected.
- The work shall be governed by CPWD specification as amended from the time to time.
- Acceptance of quotation will rest with the **Dy Comdt (Works)/Executive Engineer, Command HQ SPL OPS**, Who does not bind himself to accept the lowest quotation & reserve the right to reject any/all quotations without assigning any reason whatsoever.
- The contractor shall remain responsible for commencement of work from date of issue work order on CPWD No. 11 and the terms and conditions laid down in shall also be binding absolutely on the part of contractor.
- Time of execution of work shall be strictly followed and remains binding on the part of contractor in all respect.
- The contractor should read the specification, terms and conditions carefully before submitting the quotation.
- The rates to be quoted by contractor should include whole cost of labour, materials, all taxes and other inputs involve for the execution the items and for their completion in all respect.
