4. The highest bidder will lift the store immediately once the auction is over at his/their own arrangement within 24 hrs.
5. No transportation will be provided by the department to shift the stores.
6. The highest bidder will have to deposit the sale value of the auctioned stores and the taxes (In cash) immediately after the auction.
7. Bidders will have to submit copies of PAN card, Registration of GST no.
8. Bidders should produce their photo ID in original.
9. The stores for auction will be laid out for the inspection of the bidders at 0930 hrs on the day of auction
10. In case the successful bidder failed to lift the auctioned stores within the reasonable time, the bid will be treated as cancelled and goods and the bid security will be forfeited.
